**KHOMAS REGION**

**WANAHEDA POLICE STATION : MURDER AND SUICIDE**

On Thursday, 6<sup>th</sup> August 2015, at about 11h00, at Ehambo da Nehale Location, in Katutura, a 25 years old man stabbed his girlfriend to death with a knife, and hanged himself shortly thereafter.

It is alleged that, the suspect (later become the deceased) stabbed the victim (his girlfriend) with a knife and she died at the scene of the incident.

The suspect then ran to his residence at Gabes Location, in Katutura, and hanged himself with a cable in his bedroom at around 12h00.

No suicide note was left, the Police investigations into the matter continue.

The deceased who was stabbed with a knife was identified as Heneliate Mwetiteya Shikongo (N/Female, 19 years of age).

The deceased who hanged himself was identified as Christof Ndemweetela (N/Male, 25 years of age).

The next of kin for both deceased are already formally informed, Police investigations into the matter continue.

**GROOT AUB : HUMAN SKELETONS**

On Friday, 07<sup>th</sup> August 2015, at about 11h30, at Groot Aub, human remains (Skeleton) was discovered by public members and they notified the Police.

The skeleton was discovered buried underground by people who were digging holes to lay the foundation to start building a house.

The remains were taken to the Police mortuary for forensic examinations. Police investigations into the matter continue.

## **WINDHOEK POLICE STATION : MURDER**

On Sunday, 9<sup>th</sup> August 2015, at about 00h30, at Jokers Bar, Bell Street, Southern Industry, a 42 years old man was shot to death in his vehicle ( Land Cruiser with Reg Number N141-198W).

It is alleged that, the deceased was driving a Land Cruiser and bumped another vehicle (white, Volkswagen, Polo, sedan) from behind. The driver of the vehicle that got bumped jumped out of his vehicle and drawn his firearm (pistol) and shot randomly at the deceased vehicle, and drove away. The Police collected nine (9) spend cartridges from the scene.

The victim was declared dead at the scene of the incident.

The deceased was identified as Ronni Marco Kristian Uolevi ( Finish national, 42 years of age). The next of kin is formally informed.

The suspect is still at large, the Police are working round the clock to trace the suspect, hence investigations into the matter continue.

## **DORDABIS : MURDER**

On Friday, 07<sup>th</sup> August 2015, at about 12h30, at Dordabis, A 16 years old boy was stabbed with a knife by a 22 years old male, and died upon arrival at Dordabis Clinic.

It is alleged that, the deceased and the suspect were both attending a memorial service, and an argument ensued between the deceased and the suspect's younger brother.

The suspect intervened to protect his brother younger, which resulted in stabbing of the deceased.

The deceased was identified as Quinton Doeseb (N/Male, 16 years of age).

The suspect (N/Male, 22 years of age) was arrested and is due to appear at Windhoek Magistrate Court on Monday, 10<sup>th</sup> August 2015.

The next of kin of the deceased are already formally informed, Police investigations into the matter continue.

## **OSHIKOTO REGION**

### **ONAYENA : RAPE**

On Thursday, 06<sup>th</sup> August 2015, at about 21h00, at Omuunda Village, Onkumbula Area, a 9 year old girl was raped by a 20 years old male.

It is alleged that, the suspect found the victim in her room, and threaten to beat her with a stick and sexual intercourse with the minor. The suspect is a half brother to the victim.

The suspect (N/Male, 20 years) was arrested and is due to appear at Ondangwa Magistrate Court on Monday, 10<sup>th</sup> August 2015.

### **ONAYENA : RECKLESS AND OR NEGLIGENT DRIVING**

On Saturday, 08<sup>th</sup> August 2015, at about 18h40, on the main road between Onayena and Okankolo, at Oniwe Village, the driver of Cherv Corsa bumped five stray cattle on the road and lost control.

There were three occupants in the vehicle including the driver, the driver (N/Male, 41 years) sustained slight injuries, whereas two passengers (both males aged 36 and 39 years) sustain serious injuries.

All three occupants were admitted to Onandjokwe Luthern Hospital in a stable condition.

All five cattle's died at the scene.

Police investigations into the matter continue.

## **ZAMBEZI REGION**

### **KATIMA MULILO : INQUEST ( SUICIDE)**

On Friday, 07<sup>th</sup> August 2015, at about 23h50, at Chikali Village, Kaenda Area, a 54 years old man shot himself with his own shotgun at their residence, in the presence of his wife and died on the spot.

It is alleged that, the deceased took his shotgun and the wife asked him where he was taking the shotgun at the time of the night, he then pulled the trigger shooting himself on the head.

The deceased was identified as Libuo Oscar Gilson (N/Male, 54 year of age).

No suicide note was left, the next of kin is already formally informed. Police investigations into the matter continue.

## **KAVANGO EAST REGION**

### **RUNDU : ATTEMPTED RAPE**

On Friday, 07<sup>th</sup> August 2015, at about 20h00, at Kehemu Location, a 20 years old woman was almost raped by a 26 years old man.

It is alleged that, the victim was walking home from a Bar, when the suspect approached her from the back and kicked her down with his knee and lay on top of her, and unzip his trouser with an intention to have sexual intercourse with the victim.

The suspect (N/male, 26 years) was arrested and is due to appear at Rundu Magistrate Court on Monday, 10<sup>th</sup> August 2015.

Police investigations into the matter continue.

## **OHANGWENA REGION**

### **OHANGWENA : RAPE**

On Friday, 07<sup>th</sup> August 2015, at about 00h00, at Onekwaya West, Ohangwena Area, a 27 years old woman (Angolan national) was raped by a male suspect.

It is alleged that, the suspect went to the victim`s house (victim five months pregnant) and entered the victim`s bedroom and forcefully have sexual intercourse with the victim.

The suspect fled the scene, and is still at large. Police investigations into the matter continue.

## **OSHANA REGION**

### **OSHAKATI : RAPE**

On Friday, 07<sup>th</sup> August 2015, at about 22h00, at Oshakati West, a 26 years old woman was raped by two man, aged 24 and 26 years.

It is alleged that, the victim travelled from her village to come and meet her boyfriend at Okatana Service Station, in Oshakati, and upon arrival there, while busy on her phone to call her boyfriend, one of the suspect (who later raped her) grabbed her cellphone and walked away, she followed the suspect who walked until a friend`s place.

The suspect entered the room and the victim too entered the room demanding her cellphone back, the suspect then grabbed the victim and had sexual intercourse with the

victim without her consent, and left the victim in the room and the second suspect (owner of the room) entered and also had sexual intercourse with the victim.

Both suspects (N/Males, aged 24 and 26 years) was arrested, they are due to appear at Oshakati Magistrate Court on Monday, 10<sup>th</sup> August 2015, the cellphone was also recovered by the Police.

**ONDANGWA : INQUEST (HANGING)**

On Saturday, 08<sup>th</sup> August 2015, at about 11h00, at Omakulukuma Location, a 41 years old man hanged himself with a rope in his bedroom (renting room).

No suicide note was left.

The deceased was identified Ashikoto Samwel Hangula (N/Male, 41 years of age).

The next of kin is already formally informed, Police investigations into the matter continue.

**ONDANGWA : INQUEST (HANGING)**

On Saturday, 08<sup>th</sup> August 2015, at about 17h00, at Ehafo Village, Eheke Area, a 35 years old man hanged himself with a rope in his sleeping hut.

No suicide note was left. The deceased was identified as Kalenga Phillipus (N/Male, 35 years of age).

The next of kin are already formally informed, Police investigations into the matter continue.

**ONDANGWA : INQUEST (SUDDEN DEATH)**

On Saturday, 08<sup>th</sup> August 2015, at about 17h00, at Onakatabilili Village, in Eheke Constituency, a 93 years old pensioner collapse and died.

It is alleged that, the deceased went to receive his monthly old age grant (pension), and on the way walking home, he collapsed and died.

The deceased was identified as Nakale Sakaria (N/Male, 93 years of age).

The next of kin are already formally informed, Police investigations into the matter continue.
