## Police Crime Report for the weekend of 16 - 18 December 2016 Anro Court Building Time: 14h00

### Oshikoto Region:

1. **Inquest: Okatope Inquest 15/12/2016**

On Thursday 15/12/2016, at about 17h00, at Okatudu Village Onankali, it is alleged that the deceased was found hanging on a tree with a rope around his neck.

The deceased, Tomas Nambahu, 55 years Namibian male, no suicide note left behind, and no foul play suspected. Next of kin informed.

2. **Ondangwa:**

On 15 December 2016, at around 22h00 at Omwandi location, it is alleged that the victim took a taxi from Omwandi service to go to Ongha village, it is further alleged that the taxi driver drove straight to his room and threatened the suspect with a knife. Ordered the victim to remove her clothes and raped her. The suspect is alleged to have been driving a Toyota Corolla with an unknown registration. The victim is an 18 years old Namibian female. No arrest. Police investigation continues.

4. On 16 December 2016, at around 15h30, on the main road between Tsumeb and Oshikoto, approximately 40 km to Oshikoto a Quantum Minibus with registration number N194-733W, carrying 13 passengers is alleged to have hit a Nissan pick-up, registration number N5834W, from behind causing it to leave the road and hit a traffic sign. Both vehicles, travelling from Windhoek to Oshakati, were following one another in the process of overtaking a vehicle.

There were four passengers in the Nissan Pick-up that was hit from behind, and one died on arrival at the Tsumeb hospital. He was identified as a 35 year

old Tuyeni Tulongeni, Namibian male from Windhoek. Others who were injured were:

1. AFestus Shihepo 3 years old Namibian male
2. Hamutenya Helvi, 22 years old
3. Tommy Shipahu 49 years old
4. Simion Tuhafeni Shihepo 47 years old, driver of the Nissan pick-up.

5. **Tsumeb: Act 8/2000 Rape Nomtsoub CR 18/12/2016**

On 16 December 2016 at about 12h30, it is alleged that a 13 years old girl was raped by a 23 years old Namibian male, at his place in Kuvikiland location in Tsumeb.

It is further alleged that the victim and the suspect had consensual sex; however the suspect was arrested and charged with statutory rape.

6. **Onayena: Act 8/2000 Rape Onayena CR 28/12/2016.**

Act 8/2000 Rape Onayena Cr 28/12/16 on 15/12/2016 at about 17h00 at Okaliveva. It is alleged that the suspect had several intercourses with the minor, it is further alleged that the crime was committed in the sleeping room of the suspect, who's an uncle of the victim, while they resting. It is further alleged that the suspect forced the 14 years old victim, undressed and raped her.

## **Oshana Region:**

7. On 15 December 2016, at about 12h45, at Etango complex in Oshakati, it is alleged that the suspect broke into a room belonging to Chinese national and stole money N\$ 100 000.00 and 1000 Chinese Yuan. It is alleged that the money was kept in a shoe box. No arrest yet. Police investigation continues.
8. Culpable Homicide: Cr 152/12/2016  
On Friday 16 December 2016, at about 11h00 on the Oshakati/Omungwelume road a 5 year old Tangent Mesah was hit by a vehicle and died at the scene. The driver of the vehicle was a 61 year old Abeli Shihepo.
9. Reckless and negligent driving: CR161/12/2016  
On 16 December 2016, at about 13h20, on the Ondangwa/Oshikango main road, at Omuthiya GwaShikongo Village, a taxi with registration number N23265 SH, driven by 22 year Immanuel Atutale and carrying four passengers, collided head on with a Mercedes Benz , registration number N 14962 ND.

People in both vehicle sustain serious injuries and were admitted to Onandjokwe Hospital. Their Names are:

1. Paulus Nghikusilya 59 years Namibian male.
2. Elise Nangolo 26 years Namibian Female
3. Abed Valde 21 years Namibian male
4. Philipus Ngikushilya age unknown, admitted in ICU in Critical conditions.

5. Chameia Abeth Da Gloria, 35 years Angolan female
6. Upakila Elinaid Jenifer Da Costa 19 years Angolan
7. Lenisha Ginga Frangoso 35 year old Angolan female

The two drivers Immanuel Atutale, 22 years old Namibian male and Kinduku Kamwisiku Johny, Congolese citizen 38 years were also admitted at Onandjokwe hospital.

10. **Reckless and negligent driving: CR 96/12/2016**

On Friday 16 December 2016, at Ongwendiva/Ondangwa main road the driver of the vehicle, registration number N30497 SH, Johannes Shimoshili 56 years Namibian male from Ehafo Oshipumbu Shomungogo hit a 19 year old Nakanyala. The victim was admitted to Oshakati Hospital in critical condition.

11. **Attempted Murder: Ondangwa CR 173/12/2016**

On 18 December 2016, at about 00h00, at New Life Bar Onethindi, the victim was shot by a security guard, after an argument over a glass allegedly used by the victim. The victim, Pineas Nangundu, 28 years, shot on the left upper arm. The Suspect was arrested and will appear in Oshakati magistrate court tomorrow.

12. **Theft of Motor Vehicle: Ongwendiva CR 193/12/2016**

Between 03h00 and 04h00, at Kako Lodge Ongwendiva, the complainant parked his car at New Reception residence, a 1997 Toyota Corolla, and when he woke up this morning the car was gone. Just to be informed that the vehicle was found overturned at /or near Okatana circle. No arrest has been made. Police investigation continues.

### **Kavango-West Region:**

13. **Kahenge Inquest 2016:**

On Thursday 15 December 2016 at about 17h00 at Kamupapu Matave Village in Moses Nkando's residence, it is alleged that the deceased was sleeping in her hut, when it was struck by lightning and caught fire. Efforts were made to rescue the deceased but it was too late. The deceased was identified as Iyanga Veronica Kayando, adult Namibian female. Next of kin were informed. The age of the deceased could not be confirmed as all documents allegedly burned in her hut.

### **Kavango-East Region:**

14. **Rape Act 8/2000**

On Friday, 16 December 2016, between 02h00 and 04h00 in the morning, at Rundu Secondary School sport field, Donkerhoek location, it is alleged that the victim was on her way home from System Pub, when the suspect pulled her in to the Rundu Secondary schools sports field and raped her. It is further alleged

that the perpetrator then stabbed the victim four times with a knife in the abdomen. The victim is a 17 years old Namibian female. No arrest. Police investigation continues.

15. Rape Act 8/2000: Ndiyona CR 7/12/2016  
On Thursday, 15 December 2016 at about 22h00 hours, at Kamundema Village in Ndiyona district, it is alleged that the suspect found the victim along the foot path, as she was allegedly coming from a shebeen. The suspect forced her to the ground and raped her. The victim is a 45 years old Namibian female and the suspect, who has since been arrested, is 37 years old Namibian male.

### **Omaheke Region:**

16. On Friday 12 December 2016, at about 21h00, between Tallismanus and Lister village, a motor vehicle, RAV 4, overturned injuring:

1. Nangana (driver), seriously injured
2. Kakuena Ndjoze, seriously injured
3. Jillean Goseb Namibian male, slightly injured
4. Venaani Hangero, minor, injured
5. Ritjeveree Humbu, a 3 years old minor, minor injuries

17. **Tallismanus Inquest 02/2016:**

On 15 December 2016, at an unknown time at **Die Ou Pad** Post 2 in Rietfonteinblock, Otjombinde Constituency, it is alleged that the deceased hanged himself with a belt trap of a back inside his house. No suicide note left behind, no foul play suspected. Next of kin informed. The deceased Rudolph Kozongonda Muvangwa, Namibian male 51 years old. Post mortem will be done to determine the exact cause of death. Police investigation continues.

### **Epukiro Region:**

18. **Inquest:**

On Friday 16 December 2016, at around 20h00, 7km to Epukiro Post 3, the driver of motor vehicle registration number N3122 GO, a white Isuzu Pick-up, lost control of the vehicle and it overturned. There were 3 people in the vehicle, including the driver. One of the passengers, Gerson Nderura Murangi, a Namibian male 78 years old died at the scene while the driver and the other passenger were seriously injured.

The driver's name is Greling Vehonga Murangi, the name of the other passenger is still outstanding.

19. Du Plesis CR 02/12/2016:

On 16 December 2016, at an unknown time but in the vicinity of Du Plesis, the driver of a motor vehicle with registration number N114663W, a VW Pick-up lost control of the vehicle and it overturned causing injuries to the passengers. The driver, Godfried Pekara Semba was not injured.

Passengers were:

8. Vesisa Ruhumba, Namibian female, seriously injured
9. Kakunandjipua Kandoroza, Namibian female, seriously injured
10. Mika Hoveka, slightly injured
11. Zebald Kaunatjike, slightly injured
12. Asser Hangero, not injured

20. **Capable Homicide:**

On Friday, 16 December 2016, at about 21h30, 20km to Witvlei from Windhoek, the driver of a motor vehicle hit a warthog and lost control of the vehicle. Vehicle overturned causing the death of Operi Seun Tjombe, 29 years old Namibian male and injuring Jatatjo Handura 24 years old Namibian female seriously, who later succumbed to her injuries at the Windhoek Hospital.

Among the injured were also:

1. Uanee Hoveka, 27 years old and
2. Ngaihape Makari 20 years old.

**Otjozondjupa Region:**

21. Grootfontein Inquest 07/12/2016:

On 17/12/2016 at about 06h15 hours, at farm Gaibes Number 720 Grootfontein district, it is alleged that the deceased shot himself with his 9mm Star Pistol outside this house against the wall. The deceased was identified as 68 years old Uwe Greffmann Namibian male. It is further alleged that the deceased is the farm owner. Next of kin were informed. Police investigation continues.

22. Murder: Okahandja CR 84/12/2016

On 18/12/2016, at about 04h30. In Nau-Aib Township a 29 years old Mervin Goraseb was stepped to death and a 17 year old suspect was arrested in connection with the murder and is expected to appear in Okahandja Magistrate court tomorrow.

**Hardap Region:**

23. Murder: Rehoboth CR 121/12/2016  
It is alleged that two sisters were arguing over a boyfriend on Sunday 18/12/2016, at about 02h32, at their house in Sonder Water Block E Rehoboth, when the suspect allegedly stabbed the victim to death on the left side of the chest. The deceased Sara Skrywer was 17 years old. The 26 years old suspect has been arrested and is expected to appear in court tomorrow.
24. Hochanas : CR 05/12/2016 Malicious damage to property.  
On Friday 16 December 2016, at 02h00, at farm Ulenhorst in Hardap region, a 23 years old suspect allegedly set fire to the enclosure of two tamed cheaters. The suspect alleged threatened to burn the complainant's property if the complainant does not employ him. The fire to the enclosure was extinguished by workers and there was no injuries to the cheetahs. The suspect was arrested and is expected to appear in court tomorrow in Mariental

### **Erongo Region:**

25. Theft of Motor Vehicle: CR 94/12/2016  
The Namibian Police Force on 17/12/2016, at about 10h30 at Trans Kalahari border post arrested one Namibian citizen and one Motswana citizen in connection with a theft of a motor vehicle that was stolen in Walvisbay in the early morning hours of 17/12/2016.

It is alleged that the complainant parked his car, a white Toyota Legend Double Cab, with registration number N25371 WB in second street Walvisbay, and while still settled in the car, he was approached by a male suspect who confronted him on why he has parked his vehicle there. It is further alleged that the complainant became angry and got out of his vehicle to physically confront the suspect. That is when the suspect got in the vehicle and drove away leaving the owner behind. However the story has a happy ending as the vehicle was recovered and two suspects were arrested.

### **Zambezi Region:**

26. Inquest:  
ON 17/12/2016, at about 16h00, at old Isise Village Nanombe area . Two unidentified male persons were fatally struck by lightning where in the hut, at the residence of Mr. Mutemwa Mulyokela a Zambian national that was in Zambia at the time of the incident.

27. **Unnatural death:**

On 18 December 2016, at around 03h00, at Sibanga Village Making area, the deceased was found dead in his house. It is further alleged that the deceased went home after consuming alcohol at a local sheen, and was found dead this morning. The deceased Charles Longwani, adult Zambian male. The Autopsy will be conducted to determine the cause of death.
